**Section 2. Hazards identification**

This mixture has not been evaluated as a whole for health effects. All ingredients are bound in a polymer matrix and potential for hazardous exposure as shipped is minimal. Fluoropolymers heated above 350 C can evolve hydrogen fluoride and carbonyl fluoride as degradation products. Processing at elevated temperatures may release fumes that can cause polymer fume fever. The end-user (fabricator) should take necessary precautions (mechanical ventilation, local exhaust, respiratory protection, etc.) to protect employees from exposure to any vapors or dusts that may be released during heating or fabrication.
