**Section 2. Hazards identification**

This mixture has not been evaluated as a whole for health effects. All ingredients are bound in a polymer matrix and potential for hazardous exposure as shipped is minimal. Fluoropolymers heated above 350 C can evolve hydrogen fluoride and carbonyl fluoride as degradation products. Processing at elevated temperatures may release fumes that can cause polymer fume fever.
